Chief Booth recommended the appointment of Lt. Wayne Brooks for Deputy Chief, filling the vacancy for retiring Deputy Chief Dwight Ower.

It was moved by Commissioner DeTienne, seconded by Commissioner Flammini to appoint Lt. Wayne Brooks as Deputy Chief of Police, effective January 7, 2008, and to grant permission to appoint a Lieutenant and Sergeant in the Police Department from the Fire and Police Commission's eligibility list.
