- ◆ Before a new business license can be issued, you must obtain an occupancy permit. Please contact the Zion Building Department at 847-746-4018 for more information. A fee will apply.
- ◆ All new businesses **must** attach a copy of an executed lease agreement or Bill of Sale to this application.
- ◆ Any business that deals with food products of any kind **must** attach a copy of the following to this application:
  - An executed lease agreement or Bill of Sale
  - A valid Lake County Health Department Permit.
- ◆ Any business that provides hair or nail services **must** attach a copy of the following to this application:
  - An executed lease agreement or Bill of Sale
  - Copy of Salon/Shop Registration issued by the State of Illinois
  - Copy of the Illinois Cosmetology License for everyone that will be providing cosmetology services at the address provided in this application.
- ◆ Businesses applying for a change of ownership must schedule a walk-through inspection with the Zion Building Department and Fire/Rescue Department to obtain an occupancy permit. Please contact the Zion Building Department at 847-746-4018 for more information. A fee will apply.

**\*\*Late Charges:**

Any person not purchasing a required business licenses or permits by the required due date, shall pay a late charge as follows:

- Within first 30 days of the due date, a late charge of 10% of the business license fee will be added to the amount due.
- Over 30 days of the due date, a late charge of 10% of the business license fee plus and additional \$5.00 per day for every day over 30 days will be added to the amount due.

- ◆ Any business that deals with food products of any kind, must attach a copy of their health department permit.
- ◆ Any business that provides hair or nail services must attach a copy of their salon license and copies of the barber, cosmetology, esthetics, hair braiding and nail technology license of their employees.
- ◆ All **NEW** businesses must attach a copy of their lease agreement.
- ◆ Any business that changes ownership shall contact the City Clerk's office, and obtain a **NEW** license.
- ◆ All **NEW** businesses or a change of ownership must schedule a walk-through inspection with the Zion Building Department and Fire/Rescue Department to obtain an occupancy permit.
- ◆ A license is required for all home-based businesses. All permitted home businesses must meet the standards and conditions as established in Chapter 102, Zoning.
- ◆ All **Licensed Businesses** will be listed in the Business Directory on the City of Zion Website **free of charge**.
