# MINUTES OF A REGULAR MEETING OF THE ZION CITY COUNCIL HELD ON TUESDAY, OCTOBER 18, 2005, AT 7:00 P.M. IN THE CITY COUNCIL CHAMBERS, CITY HALL, ZION, ILLINOIS

Mayor Harrison called the meeting to order.

## AGENDA CHANGES

## ZION LIQUOR CONTROL COMMISSION

## TRICK OR TREAT HOURS

Mayor Harrison recommended changing this year's Trick or Treat hours to Saturday, October 29, in order to coordinate with the Mayor's Safe Halloween Walk.

## TAB OF BIDS/INTERIOR PAINTING/POLICE BUILDING

A Tabulation of Bids (05-DOC-149) was received from Chief Malcolm, regarding interior painting of the Police Administration Building. Chief Malcolm recommended awarding the contract to the lowest responsible and responsive bidder, Larry Lewis, in the amount of \$7,250. This is a budgeted item.

It was moved by Commissioner Flammini, seconded by Commissioner Taylor to award the contract for the interior painting of the Police Administration Building to Larry Lewis in the amount of \$7,250. The vote on roll call was: Commissioners DeTienne, aye; Flammini, aye; Taylor, aye; Bennett, aye; and Mayor Harrison, aye. Motion carried.

#### POLICE ADMINISTRATION BUILDING REPAIRS

Chief Malcolm stated it was necessary to make emergency repairs at the Police Administration Building due to a major leak. Commissioner DeTienne was notified and authorized \$4,368 in repairs to fix the problem. Chief Malcolm stated McDonough Heating will be replacing damaged ductwork.

It was moved by Commissioner DeTienne, seconded by Commissioner Bennett to authorize emergency repairs at the Police Administration Building in the amount of \$4,368. The vote on roll call was: Commissioners DeTienne, aye; Flammini, aye; Taylor, aye; Bennett, aye; and Mayor Harrison, aye. Motion carried.

#### PURCHASE OF SQUAD CARS/POLICE DEPT.

A memo (05-DOC-150) was received from Chief Malcolm, requesting the purchase of five (5) 2005 Chevrolet Impala squad cars for the Police Department. The vehicles would be purchased through a State bid contract from Miles Chevrolet for a total cost of \$91,121.60. This is a budgeted item. Chief Malcolm stated he would be requesting the purchase of accessory equipment at a future meeting.

It was moved by Commissioner DeTienne, seconded by Commissioner Taylor to approve the purchase of five (5) 2005 Chevrolet Impala squad cars through a State bid from Miles Chevrolet for a total cost of \$91,121.60. The vote on roll call was: Commissioners DeTienne, aye; Flammini, aye; Taylor, aye; Bennett, aye; and Mayor Harrison, aye. Motion carried.

#### **CITY MAPS/ADVERTISING**

A memo (05-DOC-151) was received from Delaine Rogers, requesting to place advertising on new city maps. The Chamber of Commerce has contracted with Village Profile for updated maps. The city's cost for placing an ad would be \$2,900. Ms. Rogers also recommended purchasing additional maps, so as to have a supply available at City Hall and through the Welcome Bag project. Village Profile has agreed to provide a minimum order of 7,000 at a cost of \$0.94 each for a total of \$6,580. The combined cost for advertising and 7,000 maps would be \$9,580. Ms. Rogers requested utilizing Cable Funds for this project.

It was moved by Commissioner Taylor, seconded by Commissioner Flammini to approve placing an advertisement in the Village Profile Zion map, purchasing 7,000 maps, and authorizing an expenditure of \$9,580 from Cable Funds. The vote on roll call was: Commissioners DeTienne, aye; Flammini, aye; Taylor, aye; Bennett, aye; and Mayor Harrison, aye. Motion carried.

## EASTSIDE REDEVELOPMENT

A memo (05-DOC-152) was received from Delaine Rogers, requesting to schedule a workshop regarding the redevelopment area east of Edina Blvd to the lakefront and between 25<sup>th</sup> Street to 29<sup>th</sup> Street. Ms. Rogers stated the concept plan is for a mixed-use residential and services area. This workshop would be in preparation for the Metra R-TAP Grant to be submitted later this year.

The Council agreed to conduct a Workshop/Special Meeting on Thursday, October 27 at 7:00 P.M. to discuss the Eastside Redevelopment.

#### PURCHASE OF GENERATOR/ESDA

A memo (05-DOC-153) was received from Ken Ranta, requesting permission to purchase a generator for an ESDA pickup truck. A quote was received from Monroe Truck Equipment in the amount of \$6,602 for the purchase and installation. This is a budgeted item.

It was moved by Commissioner Flammini, seconded by Commissioner Taylor to grant permission to purchase a generator for ESDA from Monroe Truck Equipment in the amount of \$6,602. The vote on roll call was: Commissioners DeTienne, aye; Flammini, aye; Taylor, aye; Bennett, aye; and Mayor Harrison, aye. Motion carried.
