MINUTES OF A REGULAR MEETING OF THE ZION CITY COUNCIL HELD ON TUESDAY, MAY 15, 2007, AT 7:00 P.M. IN THE CITY COUNCIL CHAMBERS, CITY HALL, ZION, ILLINOIS

Mayor Harrison called the meeting to order.

On call of the roll the following answered present: Commissioners Taylor, Flammini, Bennett, DeTienne Taylor and Mayor Harrison.

Mayor Harrison led in the Pledge of Allegiance to the Flag.

AGENDA CHANGES

It was moved by Commissioner Taylor, seconded by Commissioner Bennett to accept the Council agenda with amendments as follows:

- Deleting request for installation of a weather canopy at Pearce Campus, item 8.e.

CONSENT AGENDA

It was moved by Commissioner Flammini, seconded by Commissioner DeTienne that the Consent Agenda be approved as follows:

RESOLUTION OF COMMENDATION/DOUGLAS TOWNSEND

A resolution recognizing Douglas Townsend for his service on the Zion TIF Review Board will be deferred until the next regular Council meeting.

ZEDCO/DISTRIBUTION OF ASSETS

The Zion Economic Development Corporation (ZEDCO) is in the process of dissolving and must distribute its assets. The City would be accepting these funds to be used for economic development purposes. It was moved by Commissioner Taylor, seconded by Commissioner DeTienne that Resolution (07-R-9) be passed accepting a distribution of assets from the Zion Economic Development Corporation (ZEDCO). The vote on roll call was: Commissioners Taylor, aye; Flammini, aye; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Resolution passed.

WORKERS' COMPENSATION HEALTH CARE PROVIDER

The City currently utilizes Condell Acute Care Center in Gurnee for employees' work-related non-emergency injuries. Chief LaBelle recommended adding United Occupational Medicine in Pleasant Prairie, Wisconsin as an additional health care provider for treatment of such injuries.

It was moved by Commissioner DeTienne, seconded by Commissioner Bennett that a Resolution (07-R-10) be passed designating United Occupational Medicine as one of the City-Designated Employee Health Care Providers for treatment of employees' non-life threatening, non-emergency work related injuries. The vote on roll call was: Commissioners Taylor, aye; Flammini, aye; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Resolution passed.

AMENDING MUNICIPAL CODE/SOUND AMPLIFICATION/EXELON CORPORATION

It was moved by Commissioner Taylor, seconded by Commissioner Bennett that an Ordinance (07-0-20) be passed amending the Municipal Code of the City of Zion, as amended, Section 30-61 and 30-62 adding an exception for Exelon Corporation (a.k.a. Commonwealth Edison) regarding restrictions on sound amplification systems. The vote on roll call was: Commissioners Taylor, aye; Flammini, pass; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Ordinance passed.

AMENDING MUNICIPAL CODE/ESDA

It was moved by Commissioner Bennett, seconded by Commissioner DeTienne that an Ordinance (07-0-21) be passed amending the Municipal Code of the City of Zion, as amended, Sections 18-37 and 34-3, establishing the Fire/Rescue Chief as the coordinator of ESDA and ESDA operations, subject to the direction of the Commissioner of Public Health and Safety. The vote on roll call was: Commissioners Taylor, aye; Flammini, aye; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Ordinance passed.

NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM

A memo (07-DOC-47) was received from Ron Colangelo regarding the National Pollutant Discharge Elimination System. As required by federal and state law, a report and adoption of an ordinance must be submitted to EPA by June 1, 2007 for the regulation of non-stormwater discharges to the stormwater drainage system and prohibition of illicit connections.

It was moved by Commissioner Taylor, seconded by Commissioner Flammini that an Ordinance (07-0-22) be passed for the regulation of Illicit Discharge Detection and Elimination as required by the National Pollutant Discharge Elimination System. The vote on roll call was: Commissioners Taylor, aye; Flammini, aye; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Ordinance passed.

TELECOMMUNICATOR/POLICE DEPT.

A memo (07-DOC-48) was received from Chief Booth, requesting permission to post and advertise for the hiring of one part-time Telecommunicator.

It was moved by Commissioner DeTienne, seconded by Commissioner Bennett to grant permission to post and advertise for the hiring of one part-time Telecommunicator in the Police Department. The vote on roll call was: Commissioners Taylor, aye; Flammini, aye; Bennett, aye; DeTienne, aye; and Mayor Harrison, aye. Motion carried.

2655 SHERIDAN ROAD/INTERGOVERNMENTAL AGREEMENT

The City of Zion owns property at 2655 Sheridan Road, and Zion Township has expressed its interest in acquiring this property for the relocation of offices and services. The Town Board just passed an ordinance, authorizing the acquisition of the property. Attorney Randall stated the Local Government Transfer Act requires passage of a resolution for the conveyance of property. An intergovernmental agreement has been prepared, including the City's transfer of property with right of first refusal and property maintenance issues. Attorney Randall recommended that the agreement could be subject to attorney review. Trustee Bennett stated this transfer of property would be a mistake for both the Township and City.

It was moved by Commissioner Taylor, seconded by Commissioner Flammini that a Resolution (07-R-11) be passed authorizing the conveyance of certain property located within the City of Zion, commonly known as 2655 Sheridan Road, and the execution of an Intergovernmental Agreement with the Township of Zion, subject to attorney review. The vote on roll call was: Taylor, aye; Flammini, aye; Bennett, nay; DeTienne, aye; and Mayor Harrison, aye. Motion carried. Resolution passed.
