#### AMENDMENT OF VEOLIA HOST CITY AGREEMENT

An Amendment of the Host City Agreement with Veolia ES Zion Landfill, Inc. will extend the existing contract to the proposed expansion of the landfill on the 25 acres recently annexed to the City of Zion.

It was moved by Commissioner Taylor, seconded by Commissioner DeTienne that a Resolution (08-R-9) be passed authorizing an Amendment of the Host City Agreement with Veolia ES Zion Landfill, Inc. The vote on roll call was: Commissioners Taylor, aye; DeTienne, aye; and Mayor Pro-Tem Bennett, aye. Motion carried. Resolution passed.

#### PREVAILING RATE OF WAGES

It was moved by Commissioner Taylor, seconded by Commissioner DeTienne that an Ordinance (08-0-36) be passed ascertaining the Prevailing Rate of Wages as determined by the Department of Labor for laborers, mechanics and other workers performing construction of public works in the City of Zion, Lake County, Illinois. # DIGITAL VIDEO SYSTEMS/POLICE DEPT.

A memo (08-DOC-37) was received from Chief Booth, requesting permission to waive bids and purchase four (4) in-car digital video systems for Police squads. Quotes were reviewed, and the lowest price with a positive reference for this system was found from ICOP Digital, Inc. for a total cost of \$21,877.70 including software. Funds for this purchase were included in the 2007/08 budget.

It was moved by Commissioner DeTienne, seconded by Commissioner Taylor to grant permission to waive bids and purchase four (4) digital video systems from ICOP Digital, Inc. for a total of \$21,877.70. The vote on roll call was: Commissioners Taylor, aye; DeTienne, aye; and Mayor Pro-Tem Bennett, aye. Motion carried.

#### SOUTHEAST CORNER OF GREEN BAY ROAD & RUSSELL ROAD/MINOR SUBDIVISION

A memo (08-DOC-38) was received from John Jones, considering the minor subdivision of a parcel on the southeast corner of Green Bay Road and Russell Road from one lot into two lots. Mr. Jones stated Mr. Goodwin, the property owner, submitted a tax district map and plat of survey, neither of which shows a division of the property. Mr. Goodwin wishes to build a new house on Parcel 1. Commissioner Taylor questioned if a survey would be needed to show the parcel marked "exception" as a separate lot. Mr. Jones stated this parcel does already have its own separate identification and pin number.

It was moved by Commissioner Taylor, seconded by Commissioner DeTienne to approve the request for the minor subdivision of the southeast corner of Green Bay Road and Russell Road from one lot into two lots. The vote on roll call was: Commissioners Taylor, aye; DeTienne, aye; and Mayor Pro-Tem Bennett, aye. Motion carried.

#### 2414 SHERIDAN ROAD/LOT CONSOLIDATION

A memo (08-DOC-39) was received from John Jones requesting approval of a lot consolidation and minor subdivision at 2414 Sheridan Road. The consolidation will allow MRMC/CTCA to begin construction of their residence building.

It was moved by Commissioner Taylor, seconded by Commissioner DeTienne to approve the lot consolidation as requested at 2414 Sheridan Road. The vote on roll call was: Commissioners Taylor, aye; DeTienne, aye; and Mayor Pro-Tem Bennett, aye. Motion carried.
