# MINUTES OF A REGULAR MEETING OF THE ZION CITY COUNCIL HELD ON TUESDAY, JULY 7, 2009, AT 7:42 P.M. IN THE CITY COUNCIL CHAMBERS, CITY HALL, ZION, ILLINOIS

Mayor Harrison called the meeting to order.

## AGENDA CHANGES

It was moved by Commissioner DeTienne, seconded by Commissioner Jim Taylor to accept the Council agenda with amendments as follows:

## PUBLIC HEARING/APPROPRIATION ORDINANCE

Mayor Harrison opened the Public Hearing at 7:43 P.M. for the Appropriation of the City of Zion for the Fiscal Year beginning May 1, 2009 and ending April 30, 2010.

Mayor Harrison asked if there were any comments and/or questions, and there were none.

Mayor Harrison declared the Public Hearing closed at 7:44 P.M.

# CONSENT AGENDA

It was moved by Commissioner Jim Taylor, seconded by Commissioner Shantal Taylor that the Consent Agenda be approved as follows:

# **APPROPRIATION ORDINANCE**

It was moved by Commissioner Jim Taylor, seconded by Commissioner Flammini that an Ordinance (09-0-23) be passed making appropriations, totaling \$45,491,249 for all funds for the City of Zion, Illinois for the Fiscal Year beginning May 1, 2009 and ending April 30, 2010. #### PURCHASE OF 3108 ELIZABETH AVENUE

It was moved by Commissioner Flammini, seconded by Commissioner Jim Taylor that an Ordinance (09-0-24) be passed approving the purchase of certain property located within the City of Zion, commonly known as 3108 Elizabeth Avenue, for \$1.00 through the U.S. Department of Housing and Urban Development (HUD). # ACCEPTING PROPERTY DONATION/"0" 31<sup>ST</sup> STREET

It was moved by Commissioner Flammini, seconded by Commissioner Shantal Taylor that an Ordinance (09-0-25) be passed accepting the donation of certain property located within the City of Zion, commonly known as "0" 31<sup>st</sup> Street, and entering into a donation agreement with Wounded Heroes Foundation. # SURPLUS VEHICLES/BUILDING DEPT.

A memo (09-DOC-43) was received from John Jones, requesting to declare two Building Department vehicles as surplus:

1999 Chevy Malibu 2004 Dodge Dakota

Chief Lewis stated these vehicles will be used for trade-ins for the purchase of a vehicle in the Fire/Rescue Department.

It was moved by Commissioner Shantal Taylor, seconded by Commissioner Flammini to declare a 1999 Chevy Malibu and a 2004 Dodge Dakota in the Building Department as surplus. The vote on roll call was: Commissioners Flammini, aye; DeTienne, aye; Shantal Taylor, aye; Jim Taylor, aye; and Mayor Harrison, aye. Motion carried.

#### AWARDING FUNDS/PLEASANT PRAIRIE POLICE DEPT.

A memo (09-DOC-44) was received from Chief Booth, regarding the award of seized criminal funds. The Zion Police Department was awarded \$131,313.97 through the Lake County States Attorneys Office and the State of Illinois for involvement in a vehicle pursuit. The pursuit started with an officer from the Pleasant Prairie Wisconsin Police Department, and Zion Police subsequently responded at the Illinois state line. Chief Booth stated the efforts of the Wisconsin officer led to Zion being able to respond and receive these funds, therefore he recommended awarding \$10,000 to the Pleasant Prairie Police Department. Chief Booth stated seized drug funds must be used for law enforcement purposes.

It was moved by Commissioner DeTienne, seconded by Commissioner Jim Taylor to approve awarding \$10,000 to the Pleasant Prairie Police Department, as recommended. The vote on roll call was: Commissioners Flammini, aye; DeTienne, aye; Shantal Taylor, aye; Jim Taylor, aye; and Mayor Harrison, aye. Motion carried.

## **RADIOS/POLICE DEPT.**

A memo (09-DOC-45) was received from Chief Booth, requesting permission to purchase 23 portable radios for the Police Department. This purchase would update the existing radios. The total cost for this purchase from Lakeland Communication Service would be \$13,980.61. Chief Booth stated funds for this purchase would come from the seized drug forfeiture account.

It was moved by Commissioner DeTienne, seconded by Commissioner Shantal Taylor to waive bids and grant permission to purchase 23 portable radios and related accessories for the Police Department from Lakeland Communication Service for a total cost not to exceed \$13,980.61. The vote on roll call was: Commissioners Flammini, aye; DeTienne, aye; Shantal Taylor, aye; Jim Taylor, aye; and Mayor Harrison, aye. Motion carried.

## 2009 SIDEWALK PROGRAM
