### Call to Order

#### Public Comment:

#### Presentation from Gurnee ETSB:

A discussion was had between boards about the pending ETSB/Dispatch consolidation required by the State of Illinois. Presently, the City of Zion must have a plan in place to consolidate with another center by July 1, 2016. This is due to the fact that the City of Zion population is under 25,000 residents. Gurnee had expressed interest in assuming 9-1-1 dispatch responsibilities for the City of Zion.

The Gurnee ETSB board wanted to foster a conversation with what they could offer. They acknowledged they are aware that the City of Zion presently has a poor financial situation. They were willing to have the Gurnee Finance Director and Zion Finance Director meet to discuss in depth financials and start the conversation to see if both municipalities could benefit from consolidation from a financial stand point. Gurnee ETSB advised that their dispatch center has entered a growth phase and they are in the position to take on other agencies.

General questions about operations were asked back and forth. It was acknowledged by all that a series of workshops would be necessary to truly identify if this was plausible for both entities.

The Zion ETSB board acknowledged that is was best to proceed with a waiver requesting an extension to investigate this plan as the timeline set forth by the State of Illinois was aggressive.
