1. Docket 13-Z-2

Petitioner: Kaloco 5, Inc.

Request: Seeking a variance from Section 70-109 (c)(1) of the Zion Zoning Ordinance to allow the installation of a 25-foot tall ID sign at 4551 Illinois Route 173.

Nick Gianaris, president of Kaloco 5 Oil Company stated that his company is not the owners of the vacant gas station at the corner of Greenbay Road and Route 173 in Zion. Mr. Gianaris asked for an amendment to the variance request to change the height to 26.3 feet.

It was motioned by Mr. Garriga and seconded by Mr. Isley to amend the applicant's request to the variance request to change the height to 26.3 feet

Director Ianson stated that the drawings have met all the set back specifications and that staff recommends this variance.

Mr. Isley asked why would the sign need to be taller. Mr. Ianson stated that the extra height is needed signage for two-tier gas pricing, pricing for carwash and the possibility of an additional of a food service business next to the gas station that would require signage.

Mr. Garriga asked if this would be the only signage for the entire square. Mr. Ianson stated this would be the only ID signage. He said that there would be directional signage located off of Greenbay Road as well as signage on the building.

Mr. Burkemper asked how tall were the signs for the drugstore and other gas station. Mr. Ianson did not know. Mr. Burkemper shared his concerns of starting a sign war.

Mr. Gianaris stated that the two tier pricing would show gas prices with and without a carwash. He also stated that they are currently talking with a national restaurant chain for the adjacent property, which will demand to be on the signage. He also stated that Shell currently has an agreement with Jewel in which customers who buy groceries at Jewel will get \$.05 cents off per gallon. This is a mandatory requirement from Shell that is required to be placed on the sign.

Mr. Burkemper asked why does the signage need to be so big. Mr. Gianaris stated that this is what is being required of him from Shell.

After reviewing the Finding s of Facts, it was motioned by Mr. Burkemper and seconded by Mr. Quinn to recommend approval of the Application for Variance
