Petitioner: Orion Asset Management

Request: Seeking approval of Final Plat of Subdivision of 21.4 acres located at 0 Russell Road (PIN 03-01-300-046) to develop and operate a pharmaceutical manufacturing facility.

Dan Shapiro, attorney for the Petitioner, stated that his client, Orion, is purchasing 21 acres in the Trumpet Park subdivision for the construction of a \$60–\$100 million manufacturing plant that will produce IV bags and other dialysis products. Construction is expected to start late 2025 and will be completed in three phases over 10 years. At completion, the project is expected to create 300 full time jobs.

Commissioner Champine asked if the project will encroach the wetlands. Attorney Shapiro said no. Acting Chairman Heffelman asked if the plant will manufacture chemicals or just assemble. Attorney Shapiro said that right now the plant will just assemble.

After reviewing the Findings of Facts, it was motioned by Commissioner Champine and seconded by Commissioner Johnson to recommend approval of the Petitioner's application.
