NOTICE IS HEREBY GIVEN that Early Voting for the November 3, 2020 General Election will commence on Thursday, September 24<sup>th</sup> at the County Clerk's Office, and conclude on Friday October 16<sup>th</sup>. Hours for Early Voting at the County Clerk's Office (Courthouse Lobby), will be Monday through Friday 9:00 a.m. to 5:00 p.m. Early Voting will extend to the additional **seventeen** sites in Lake County on Monday, October 19<sup>th</sup> and end on Sunday, November 1<sup>st</sup>. Hours for Early Voting for all Lake County voters are Monday through Friday from 8:30 a.m. to 7:00 p.m., and Saturday and Sunday from 9:00 a.m. to 5:00 p.m. The four State Mandated Early Voting sites will remain open on Monday, November 2<sup>nd</sup>, from 8:30 a.m. to 7:00 p.m.

Grace Period Registration and voting will be offered at all Early Voting locations.
