

CITY OF ZION TOWING REQUIREMENTS

In an effort to establish a reasonable response time, especially in inclement weather conditions, only tow agencies that can provide the response time below will be considered.

40 minutes response time from 6am to 6pm.

60 minutes response time from 6pm to 6am

The storage facility need not be at the agency location but said storage site must be within City limits. Tow agency must be available 24 hours a day by phone.

Tow agency must have access (ownership preferred) to the necessary equipment to handle all types of tows (i.e.: regular tow truck and a flat bed). Tow agency must have the proper equipment to clean and remove from the scene any debris at no extra charge. It will be the responsibility of the tow agency to clean the scene. Tow agency must be able to respond to multiple tow calls. Tow agency must have a secure storage area (i.e.: a fenced-in storage area with video surveillance).

I certify that I have access to towing equipment including a regular tow truck, a flatbed tow truck, and heavy-duty equipment capable of towing all types of vehicles.

I certify that I have access to the proper equipment to clean and remove from the scene of all tows any debris caused by the vehicle or vehicles to be towed as directed by the Police Officer in charge of the scene.

Tow agency must carry the proper amount of liability insurance and be bonded as required by the State of Illinois. Supporting documents must be filed with the City Clerk, City of Zion. City of Zion is to be named additional insured.

I certify that I'm bonded; and carry the proper State of Illinois required liability and vehicle insurance to operate a vehicle towing agency.

Supporting documents for 1) bonding in the amount of \$5,000 and 2) insurance, including liability in the amount of \$2,000,000 per occurrence, or commitment for such insurance, are included.

Yes _____ No _____

There is to be no charge for towing city owned vehicles less than 20,000 pounds or for the storage of any City owned vehicles. There will be no charge for police tows, with the exception of seized vehicles where a \$75.00 fee would apply.

I understand that there is to be no charge for towing service or towing and storage of any City of Zion owned vehicles, which weigh less than 20,000 pounds. This also includes no charge tows and storage of Police tows as listed above.

Storage charges will begin 24 hours after towing. It shall be the responsibility of the tow agency to collect all towing fees. Vehicles towed to the Zion Police Department for processing and then towed to the tow agency shall be deemed one tow with no additional charges. Tow agency to submit fee schedule for items below.
